Eleven years ago Good Samaritan Health and Wellness Center opened its doors to provide much needed care to the underserved and uninsured residents and workers of Pickens County. Over the years, the Center has grown from three modular units to seven. These modular units have accommodated over 8,046 patients who have received medical, dental, vision and mental health care. The time, however, has come to replace these aging modular units with a more permanent facility so that we continue to meet the growing needs of the community.

On January 24, 2013, the Board of Directors voted unanimously to retain the services of Coxe Curry and Associates to conduct a capital campaign to help us raise the funds needed to construct a new clinic. In addition, a \$500,000 Community Development Block Grant has been applied for to assist the Center with a major

portion of the initial building costs. The goal is to build the new facility on our existing site in three phases. Each phase will add a wood-frame-on-concrete-slab clinical building. As modular units are removed, space will be freed up for future phases and additional parking. We are hopeful that all phases of the project will be completed by 2016.

The demand for services offered at Good Samaritan has grown to more than 14,000 patient visits a year. In addition, the impact that the Affordable Care Act (ACA) will have on the Center along with the State of Georgia's current policy not to expand Medicaid eligibility will make Good Samaritan's services to the community more important than ever. As the new permanent facility becomes a reality, the Center will expand its service hours to include evenings and weekends to serve patients with inflexible work schedules. We have also applied to the U.S. Health Resources and Services Administration (HRSA) so that we can also serve the needs of Medicaid and Medicare patients. Reimbursements from Medicaid and Medicare patients will provide the Center with financial resources to help offset the expense of expanding service hours and increased patient visits each year.

On behalf of the Board of Directors of Good Samaritan, thank you for your faithful support in financially investing in helping us build a healthier community for all who live and work in Pickens County. We could not accomplish our many successes without your continued support. I hope that you will join us in helping us reach our goal of taking Good Samaritan Health and Wellness Center to the next level so that future generations will be able to benefit from the quality healthcare that can be found at Good Samaritan.



Effective May 23rd, 2013, I submitted my resignation as Chairman of the Board of Good Samaritan Health and Wellness Center. It is with sadness that I depart from Good Samaritan during this exciting time in the life of the clinic. We have an excellent new Board Chair in Jeff Downing. CHARITABLE PLANNING OPPORTUNITIES

The American Taxpayer Relief Act of 2012 brought some new tax rates and some charitable planning opportunities with it, especially to those who are in the top tax bracket in 2013. The new tax rate for taxpayers with taxable income above \$400,000 (\$450,000 for married taxpayers) is now 39.6%. In addition, the top rate on qualified dividends and long-term capital gains for taxpayers in the top 39.6% bracket increased from 15% to 20%. And, the Medicare surtax is in addition to these top rates bringing the capital gains rates on top taxpayers from 15% to 23.8%, a 58% increase!

So, what does this mean for gift planning? It is still advantageous to donate appreciated property, transfer funds from your IRA directly to charity or establish a Donor Advised Fund. For example, if you had \$100,000 in long-term appreciated stock, that was purchased for \$20,000, and in the top tax bracket:

	<u>Gift of Cash</u> vs.	<u>Gift of Stock</u>
Sell stock, donate after tax to charity	\$100,000	\$100,000
Cost Basis	N/A	20,000
Capital Gains Tax if Sold	N/A	80,000
Capital Gains Tax Avoided	0	19,040
Tax Savings on Charitable Deduction	39,600	8,640
After Tax Cost of Gift	\$60,400	\$41,360

Publicly-traded stock is one of the most popular types of assets to use for charitable giving purposes because it is often highly-appreciated, is easily valued and can be transferred quickly and conveniently.
