A message from the Chairman, March 2015

On Monday, March 16, 2015 the first of our three new buildings opened for business. What an exciting benchmark in the history of Good Samaritan Health and Wellness Center! This first permanent building, named in honor of Dr. Wilber, will allow Good Samaritan to better provide for the uninsured of our community, medical, dental, vision and mental health services as we all work together to fulfill the mission of Good Samaritan.

And speaking of working together, what a great example of teamwork was demonstrated in making this vision of a new, permanent Good Samaritan Health and Wellness Center a reality, with the completion of the first building phase. We are so very fortunate to have such a great, dedicated group of volunteers, donors, building committee members, capital campaign committee members, construction volunteers and others who have made this happen. The Episcopal Charities Foundation coordinated volunteer groups from various churches, some of whom came several times. Local churches and other local businesses provided lunch for the working groups. And, of course, Carole and Melinda worked along with all of these others to make it happen. It was truly a team effort.

All of this would not have been possible without the support we received from Pickens County, The City of Jasper, and financial support from our individual donors and several foundations including PCCRA. As a result of their generous support we will complete our new facilities without debt, somewhere near the end of 2016.

Meanwhile the day to day activities (and expenses) of Good Samaritan had to also be supported financially. Our donors and supporters continued to do this, despite many of them simultaneously supporting our Capital Campaign.

Building 2 should start construction in June. It will be a 2 story building approximately twice the size of the first building and upon its' completion all of our well used trailers will be retired. The architect is currently working on construction plans. We were fortunate to receive a \$500,000 Community Development Block Grant which will be used as part of the \$1.8 million needed for the second phase of construction.

Our Capital Campaign surpassed its' 2014 goal of raising \$2.48 million, and we are within reach of our ultimate goal, although we are not quite there yet. These fund raising efforts will continue in 2015. Again, a debt of gratitude is due the people on our Capital Campaign Committee, as well as Coxe Curry and Associates, who served us well in this effort.

On behalf of the Good Samaritan Board of Directors thank you for your continued financial support. We promise that your donations will be spent wisely as we complete a health complex that will continue to serve the people of our community well.

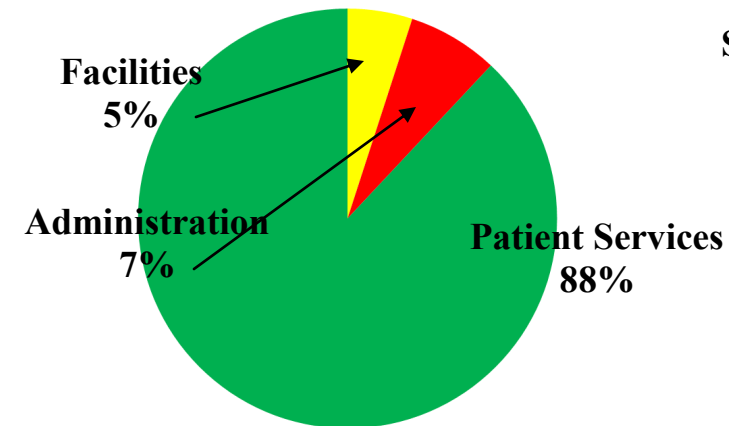

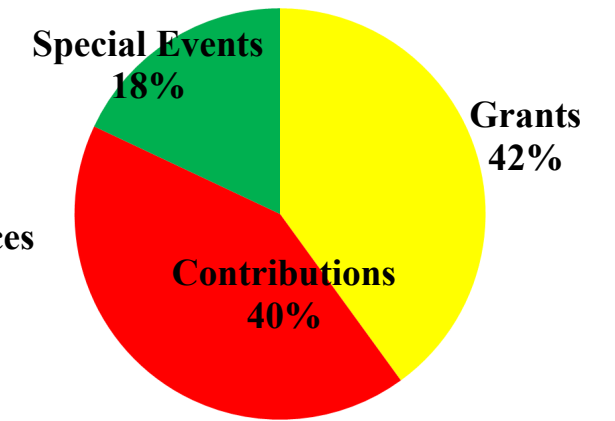

2014 Expenses

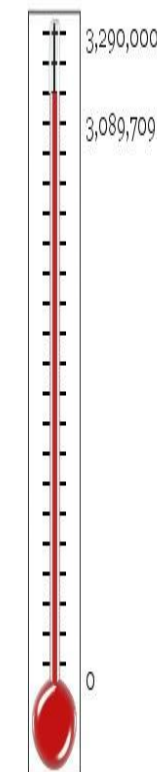


2014 Income
