These are exciting times for the Good Samaritan Health and Wellness Center. Increment 1 of our new facility is under construction at last! We owe a great debt of gratitude to a number of people who have been working on this for the past 4 years. Our Building Committee, headed by Miller Andress, have spent many, many hours planning and designing the new buildings in conjunction with Carole and many of our volunteers. The end result will be a facility that provides better care for our patients for many years to come. Miller has asked to be a bit less involved going forward, so Brad Herren has assumed the Chairmanship of the Building Committee.

Our donors have made, and continue to make the needed financial support that will result in completion of this project. Their donations will be spent wisely as we complete this project without debt. Many of our suppliers are stepping up to the plate with donated time and/or materials allowing cost reductions.

As you are aware our Capital Campaign is well underway. Our goal is to raise 2.48 million dollars by the end of 2014 which will result in the completion of increments 1 and 2. As I am writing this we are at 44% of this goal raised or pledged. Thanks so much to Ed Delaney, Development Chair, our Capital Campaign Committee, and especially to all of our generous donors who have stepped up with gifts or pledges. This campaign is a three year effort so pledges can be made over that time. Our efforts will continue until we reach our goals.

Another bit of exciting news is that an anonymous donor has given a large contribution and issued a challenge that may result in the first building being named in honor of Dr. Joe Wilber.

On behalf of the Good Samaritan Board of Directors, our volunteers and staff thank you for your continued financial support and investment in a new facility that will continue to serve this community for many years.

Jeff is the owner of Foothills IGA Market in Marble Hill, Georgia. Congratulations Jeff on winning this prestigious award!

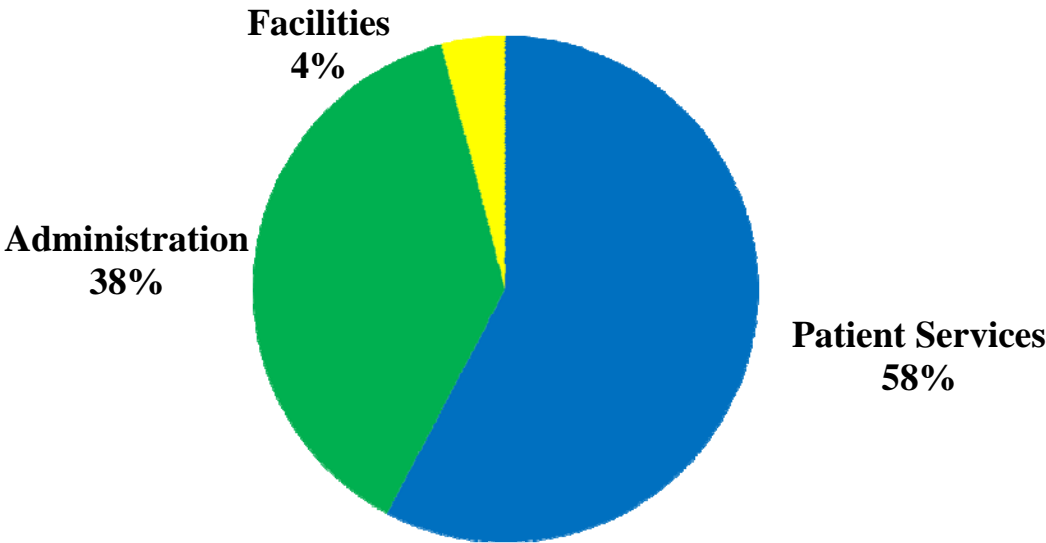
## JOB OPPORTUNITY FOR PART-TIME CLINICAL DIRECTOR

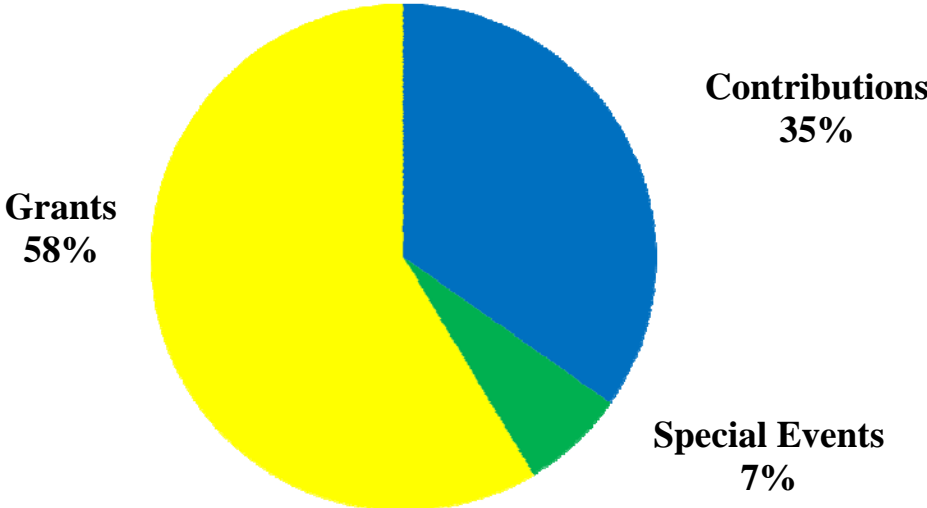

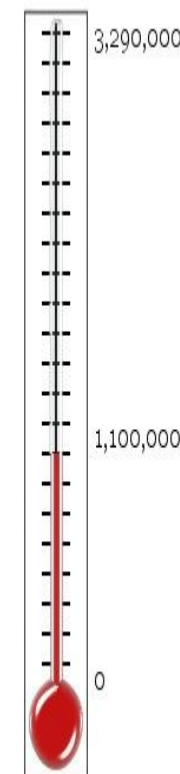

CAMPAIGN GOAL



Good Samaritan Health & Wellness Center recently launched a capital campaign to build a new, permanent clinic to be built in three (3) phases on our current site. The concrete has already been poured for phase 1, a 4,752 SF building, with construction to be completed by the end of 2014. Phase 2, a two-story, 8,250 SF building, will begin construction in 2015. Space will be freed up for future phases and additional parking as modular units are removed. Phase 3 will be constructed if we reach our goal of raising \$3,290,000.
